5. Check the websites frequently to see if there are changes in the timeline or other information.
6. The proposed VW settlement affects cars sold or leased before September 18, 2015 with defective 2.0 liter diesel engines. **It does not cover cars with 3.0 liter engines.** This is a list of the cars currently covered:

7. VW will notify all owners and lessees about their legal rights after the settlements are final. The Court settlement will not be final until at least October, 2016. The buyback or fix and customer restitution payment program will begin after that.
8. You will also receive notices from the class action lawsuit with important information about the legal rights of owners and lessees. You will also receive notices from the Court about your rights. Read those notices carefully.
9. Make sure your car is eligible: only 2.0 liter engines qualify on certain models. Check either website for a list of cars that qualify.
10. By late July, the VW settlement website will let you put in your Vehicle Identification Number (VIN) number and tell you if your car qualifies for the program. If your car qualifies, the VW website will also let you know how much your car is worth and how much you may receive in a restitution payment.
